
During this quarter we have also managed to deepen our community engagement with young women and community members through the established young women groups and community platforms in Kongwa and Nzega districts.

QUARTERLY UPDATE



To achieve its overall goal in advancing GENDER EQUALITY and empower young girls, Msichana Initiative employs these four Strategic Goals that are key programmatic areas of our work within the community. Here are our achievements for each goal in this 2nd Quarter.



DISCRIMINATORY LEGAL FRAMEWORK AND DRACONIAN LAWS CHANGED

The Law of Marriage Act, 1971

Augmented Collective Understanding among Stakeholders on the Concepts of Rule of Law, Separation of Power and Independence of Judiciary in Amendment of Law of Marriage Act,1971.

On the commemoration of Day of African Child (DAC) under this year's theme 'Eliminating Harmful Practices Affecting Children: Progress on Policy and Practice since 2013' Msichana Initiative convened a Symposium on 18th June, 2022 which brought together stakeholders from the Legal fraternity, women's rights movement and selected Member of the Parliament to hold an intellectual discussion reflecting on the issues of the Rule of Law, Separation of Power and Independence of Judiciary with regards to the amendment of Law of Marriage Act 1971 and the case of Rebeca Gyumi Vs. Attorney General (Civil Cause No. 5 of 2016). The discussion reflected the issue of compliance and the urgency to amend the Law of Marriage Act, 1971 as directed by the Court of Appeal almost 3 years ago.

MILESTONE

As an outcome of the Symposium discussion, Hon. Aida Khenani (our champion of Ending Child Marriages) presented to the Parliament our Agenda and the importance to amend the Law of Marriage Act, 1971.

"The government has played a big role in securing children's dreams, especially ensuring a girl child is protected by establishing fee free education from Ordinary level to Higher level. If we have shown these good intentions, we should then commit ourselves towards a more permanent solution in protecting the right to education. The highest court in our country (The Court of Appeal) already made a decision in regard to the Law of Marriage Act, 1971 and mandated the Law to be amended within one year. It has been three years and no amendments have been made yet. I would like to remind the Attorney General that The Court of Appeal has final decision in dispensation of justice, the good intentions of the Government should be seen by amending this Law."

Pad Taxation Policy

Enhanced Public Awareness by Conducting a Survey and Publishing an Analysis on the Implication of Tax on Pads to Young Girls in Tanzania.

Reached

On Menstrual Hygiene Day, 28th May, 2022 (MHH), Msichana Initiative published an analysis in 3 different Newspapers (The Citizen, Majira and Raia Mwema) on the 'Implication of Taxation on Pads to Young Girls in Tanzania' to create public awareness and debate. In this course, we conducted a simple survey (4 Focus Group Discussions) in 2 primary schools in Dar es Salaam through our in-school club program, a mobile survey with 3 out of school girls in our platform and interviewed 2 young women leaders to collect and document their opinions on Tax on Pads.



Focus Group Discussions were conducted by Msichana Initiative's program officers with members of Msichana Amani Clubs in Mlimani Primary School and Ubungo Primary School respectively.

Re Entry Law/Policy

Successfully Conducted Analysis on the Implication of Re-entry Policy in Tanzania.

Msichana Initiative in this quarter conducted a desk review analysis as an opinion piece Interpreting the position of young mothers in Tanzania in acquiring their right to education and highlighting gaps and opportunities in regards to the adoption of Re-entry Policy and the provided Guidelines.

The analysis is yet to be published, however some of the insights from the survey indicate the need to employ a holistic approach if young mothers are to benefit from the policy change. Issues like child care, costs associated with going back to school, psycho-social support need to be addressed more urgently if we are to reap the benefits of having the re-entry guideline in place.



GIRLS RIGHTS PROTECTED AND ENFORCED

EVIDENCE BASED INFORMATION ON VIOLENCE OF GIRLS' CHILD SOUGHT FOR BY 2022

50 Young Feminist Mapped and Engaged to Scope the Situation of Young Feminist Organizing in Tanzania.

Msichana Initiative conducted 3 consultation meetings with Young Feminists in Tanzania to deep listen to existing movements as well as an initial assessment mapping phase to understand the needs of young feminists in the region in terms of support (financial, social, mental etc.) and how to decentralize funding streams to ensure accessibility to young feminists. The participatory research is still ongoing with expectation to disseminate finding by quarter 4 of 2022

STRATEGIC INSTITUTIONS MANDATED TO ENFORCE AND PROTECT GIRLS' RIGHTS ENGAGED BY 2022.

NPA/VAWC COMMITTEES

Msichana Initiative works with the already established protection mechanisms to enhance protection of girls' rights through working with Women and Children Protection Committees NPA/VAWC Committees established under the National Plan of Action to End Violence against Women and Children (NPA/VAWC 2017/8-2021/2). In Engaging the committees one of Msichana Initiative's goal is to raise awareness and advocate for the minimum legal marriage age for young girls in Tanzania and sexual reproductive health and rights for girls.

MSICHANA CAFÉ

Msichana Initiative works directly with the community through these platforms (Msichana Cafés) which allows community members to voluntarily join without due regard of their age, sex, class or any other factor. The platforms give an opportunity for members to regularly meet to debate, discuss and digest solutions against Child Marriages, Teen Pregnancies and other challenges young girls in their communities.

Members of Msichana Cafés take Initiatives to report Gender Based Violence cases to Local Government Authorities, Police Gender and Children Desks but also educate young girls and communities in schools, health centres, markets, and gatherings on the need to End Child Marriages and protect a girl child.







In Bahi, Dodoma Child marriage has decreased by -10% this quarter compared to the previous quarter which implies awareness and change of attitude among community members.

One Girl One Bike



Education is one of the fundamental rights that every child should get. However, girls in more are а disadvantaged position in enjoying this right due to challenges they face like long walking distances to school that increases vulnerability associated with SGBV and poor academic performance of young girls caused by tiredness and absenteeism. The rationale behind our One Girl, One bike project is to cure some of these challenges and give a Girl Child an opportunity to thrive.

Reduced Risk of Violence to 50 Girls through Bike donation.

Msichana Initiative on 19th and 20th June, 2022 donated 50 bicycles to 50 Girls from Puge Secondary School and Mwanhala Secondary School at Nzega District in Tabora Region.




Girls Empowerment in Agro-Ecology and Permaculture (GAPE)

Msichana Initiative continue to implement GAPE Project in Kongwa, Dodoma and Nzega, Tabora in cooperation with SAT (Sustainable Agriculture Tanzania) and help building the confidence of girls and their ability to stand up for their rights on one hand and provide them with vocational training and support them in creation of micro/small business around agroecology.

Beneficiary Psychosocial Needs Identified.

Msichana Initiative conducted training on psychosocial support for 26 groups of GAPE project beneficiaries (14 groups in Kongwa, Dodoma and 12 groups in Nzega, Tabora) with 25 Beneficiaries each group. The training aimed to equip beneficiaries with knowledge and increased capacity in conducting psychosocial assessment to better determine recipients support type needed.

59.6% Program beneficiaries were assessed on their risk environmental situation to enable them to come up with an individual risk management plan.

- **2%** of beneficiaries were linked with the existing government structures for further steps after risk assessment to get the needed help.
- **45%** of parents committee representatives were linked with the beneficiaries purposely to influence their commitment on supporting sustainability of the program.

SEXUAL REPRODUCTIVE HEALTH AND RIGHTS.

MILESTONES

Impacted 596 GAPE Project Beneficiaries with Sexual Reproductive Health and Rights Training.

In this Quarter, Msichana Initiative conducted consecutively trainings on Sexual Reproduction Health and Rights for 26 groups of our GAPE project beneficiaries (14 groups in Kongwa, Dodoma and 12 groups in Nzega, Tabora) with 25 Beneficiaries each group. The trainings aimed to equip and empower young people with information on Sexual Reproductive Health and Rights and to impart knowledge and ability regarding relationships, sexuality, emotional and physical health as well as bodily autonomy.

Impact Story

A Survivor of Child Marriage Case becomes a Champion in Bahi District, Dodoma.

A 16-year-old Upendo (name has been changed for protection) from Bahi was married off to a 29-year-old man for a dowry of 2 cows, 10 goats and Tsh. 400,000/=. Marriage life was full of controversy and conflict but every time Upendo reported to her parents, they always advised her to persevere as that is what marital life is all about. After some time, Upendo could no longer bear it and had to report the same to one of our Msichana Café leaders in Bahi who reported her case to the Ward Executive Officer (WEO). An inquiry was conducted and all perpetrators of marrying Upendo at a young age were arrested and taken to Court (Zanka Primary Court). In Court, they read the charges and they all admitted to the claims. Moreover, they urged that they lacked an understanding on the impact of Child Marriage especially to a Girl Child and asked to be pardoned. Later on, the Court made a Ruling that nullified and dissolved the marriage.

After this decision, Upendo is now free and has been a championing against Child Marriage. She participates in concerts and conferences to offer education on impacts of Child Marriage and recently she has been participating in the establishment of several new Msichana Cafés in Kongwa District to educate community members about child marriage. Upendo continues to share her testimony to encourage other Young Girls to stay in school and the community to End Child Marriages.
